I am enclosing 18 pages that conclusively prove that the 'police' are a problem in the Cayman Islands. I have sent this to each commissioner since Thursfield in 2000 and received absolutely NO RESPONSE. The complaints commissioner, John Epp will not talk to me, and one tainted politician (McKeeva Bush) has made my life a living HELL for over 16 years.

If I am any judge of local conditions having lived here for 28 years, the climate for foreign nationals has become extremely chilly. Learning that we are at the mercy of criminals and do not live in a land ruled by law, I am leaving – having sold my properties for half their value. The world has been led to believe that the Cayman Islands are a “Crown Colony” and stable. Having faced no less than 28 assassination attempts and 170 assaults (4 by the West Bay police), I strongly disagree with that statement. I have no less than three major drug dealing operations ongoing on or around my property, thank you so much McKeeva Bush. There truly is a two class system in Cayman, in which non-Caymanians have absolutely no rights whatsoever, especially in terms of police protection, protection from Lands & Survey or protection from Planning.

Since my missive of 18 months ago, there have been several other incidents of ever increasing danger and threat to my personal safety. In January of 2007, a friend of mine (at the request of the police) tried to take pictures of licence plates of vehicles illegally parked on my land in violation of a Grand Court restraining order. Apparently a person (living partly upon my land illegally) claimed that I was present with an offensive weapon. Three squad cars (and seven officers) came up to and surrounded my house, (at least three were at the superintendent level) attempted to invade my house. I wasn't even there, but my friends Name Withheld, Name Withheld and Name Withheld were, and they were appalled at the nature of the unreasonable show of force in response. This is the constant “excuse” for not enforcing the law, or the court order, by repeatedly trying to incriminate me and trade off “dropping charges.” If there was any justice in the Cayman Islands, while the seven police officers were here, why didn't they ticket and have removed the cars which were illegally parked on my land, which was the trigger of the entire incident? As Commissioner Thursfield once said to me, “there are two sets of law, one for Caymanians and one for non-Caymanians.” There is no law to protect the white man in the Cayman Islands. I have this on video tape, if you'd care to see it.

In February 2007, Name Withheld and Name Withheld, at the request of my attorney and the West Bay Police (what's wrong with them, don't they have squad cars & sworn officers, rather than placing ordinary foreign nationals in danger?) were asked to take further photos. They were pelted with rocks and conch shells for their efforts. Mr. Name Withheld was injured (medical exam on file) and his new camera damaged. The damaged camera was taken by the police ostensibly as evidence and “lost,” never to be found or returned. The rock throwing miscreants again tried to file charges. For the record, Name Withheld was nowhere near the scene. Since there was actually bodily harm and photos of one of the miscreants actually throwing a rock, why was no arrest made? I can assure you that if the situation was reversed, the foreign nationals would have been immediately arrested and locked down! The police attended at this time, and tried to find cause to arrest Name Withheld & Name Withheld!

Shortly after this, I found the name tag of the Chief Inspector for West Bay, Angelique Howell at the end of my 20 foot sidewalk. I called the West Bay police station, and Angelique attended my house wearing no name tag, recovered her name tag and affixed it to her uniform, in front of two witnesses. What kind of behavior is this? The very commander of the district was skulking around the house late at night! Was she defending my person or my property? I sincerely doubt it! It was more like I was being stalked! Due to her obvious lack of breeding and manners, she has repeatedly and constantly violated my rights at the behest of a rather powerful and tainted politician. By this time she had been stalking me for at least 5 months with the intent of finding some (or any) excuse for arresting and incarcerating me.

There were numerous other incidents in the first half of 2007. I had been constantly surveiled, and my car has been followed by the police. This leads me to believe that an organized attempt by the police was made to find any excuse to arrest and incarcerate me. One of the “ring leaders” of this action was Sgt Smith who has consistently harassed me for many years.

In late June, *Name Withheld* accompanied me to a location where a laundry line was erected, easily over 150 feet inside my property line. The laundry line consisted of electrical wire which likely was stolen from my middle building. While trying to remove this trespass, I was assaulted with deadly force with a large rock and struck in the head, was repeatedly kicked and then dragged back to my car. At this point I was only semi-conscious. Mr. *Name Withheld* took me, bleeding profusely to the West Bay police station. The officer on duty (PC Menzies) concluded (without any physical examination) that I (the victim) was intoxicated, took photos but refused to take a report. When I returned home, I examined myself in the mirror, and being a certified military medic determined that my pupils were unequal, indicating a concussion. Mr. *Name Withheld* visually confirmed this as well. I took a large quantity of aspirin and went to bed, as treatment for concussion.

The following day, at about 5PM my home was again **INVADED** by 5 of your people who are so intent on arresting me, three of whom were high ranking officers. They searched my house for ‘firearms,’ which seems to happen every time a neighbor involved in illegal activities complains. **NONE** have ever been found! I was then led to the police station (in handcuffs) and locked down in the putrid West Bay lock-up for 40 hours. **NO** prosecution ensued. This lockup was full of fecal matter, urine, and one rather obnoxious image was cemented to the ‘bed’ apparently with human semen. When the lights were turned out, there was no way to find the toilet except to walk until you hit porcelain, lift the lid with your shoe and pee until you hit water! The ‘food’ that was offered during this period was impossible to eat. For a person who is definitely among the upper classes and a major property owner, this behavior is totally unacceptable. When I was later brought before the court, Magistrate Margaret Ramsay-Hale queried as to why I was there, and told me to “get out of my courtroom” on my own recognisance, as there was no legitimate reason to hold me in lockup! Again, **NO PROSECUTION ENSUED**. Two crime were committed. The first was my false imprisonment by the West Bay police, under Chief Inspector Angelique Howell. The second was failure to immediately arrest and confine the true miscreants. Part of the punishment for anyone involved in this travesty should be to experience the same 40 hours of confinement in the same West Bay lockup enduring the same conditions found there, followed promptly by deportation! There is no apology nor compensation which could be offered me that would be satisfactory or be adequate to right this basic wrong.

The miscreants were subsequently arrested and charged, but **NEVER** incarcerated. Their mention has happened, and a trial date has been set for August 8th, 2008. *Name Withheld* was present and called during the mention, despite never having been served! This is proof of a further attempt to pervert the course of justice, by falsely recording service of summons without actually having done so! He further has not been summonsed for the trial, leaving them with only one witness, who was basically unconscious during the crime. If the legal department follows its normal behaviour, the two miscreants who attempted to kill mee will be charged with simple misdemeanor assault and fined \$50 each, which they will never pay! Reverse the tables, and I would surely receive 5 years imprisonment, which is the normal penalty for the crime committed. Even your officials say that there is no justice for a foreign national, and there is no protection from (multiple convicted) local drug dealing scum.

Since these incidents, the harassment has continued. I have been shadowed by police in both marked and unmarked vehicles on numerous occasions when I leave the property, as well as **ON** my property. I am in fact physically afraid to approach within 300 ft of my property boundary. Part of my fear is assault from the criminal Caymanians who live in the area, but in fact this fear is exceeded by the fear of again being arrested and locked down for no reason. If you wish to take the lordly position that foreign nationals are less than human beings, without the right to equal protection under “the law” by all government agencies, then it is my job do whatever I can to see to it that decent people no longer come here at all. Any further harassment of me or wrongful imprisonment will go immediately to the Privy Council as a civil rights

issue, as the local Governor, Chief Secretary, Complaints Commissioner, nor any Police Commissioner since 2000 will even talk to me.

If you look at this plus the attached 18 pages, it will become clear that I have exhausted all legal remedies (including massive legal costs and many different attorneys, each of whom has been scared of the case) with no relief in sight. In December 2007, I attained Caymanian Status, after having been legally resident here for just short of 28 years. This despite the fact that the “law” mandated that I receive it many years earlier, based upon naturalization April 23, 1993. Every conceivable road-block was thrown in my path. Two weeks later, I sold out ALL my properties on a land contract basis. Since I am a citizen, I will leave when and to where I want, and return at my leisure.

The year 2008 hasn't been very kind to me either. While lying in my ocean-front hammock in front of my house and far from the “troubled areas,” and which I own but are not under my control, I have endured two deadly assaults by person or persons unknown. Again, an atmosphere that a Caymanian can do anything to a foreign national with impunity has pervaded this society. The most common threat used is “I will get your work permit revoked and have you deported.” I have heard this at least 500 times directed at me, even though I have never held a work permit, and have been a permanent resident for over a quarter century! However these threats against an innocent person working here strikes terror into anyone it is directed at. I respectfully suggest that any such threat uttered be punishable by fine and imprisonment.

All of the above information and considerably more is going to be disseminated either in book form, on the internet or both. This country which is presently out of control should not be allowed to do to me what has been done. Despite your blatant disregard of my rights in the past, will someone now please respond?
